Simply stating results without explaining their meaning in context is insufficient. Students might present a p-value without discussing its implications for the hypothesis.

5. Ignoring or Minimizing Limitations

A robust statistical analysis acknowledges uncertainty. Failing to mention potential biases or the limited scope of the study undermines the credibility of the conclusions.

6. Poor Communication and Organization

Even with sound statistical reasoning, a poorly written or disorganized response can be difficult to follow. Clear, concise language and a logical flow are essential.

Strategies for Mastering the AP
