Specialty contact lenses and toric eyeglasses are designed to correct astigmatism by compensating for the uneven curvature.

Presbyopia

The AAO advocates for lifestyle adjustments, artificial tears, prescription eye drops, and in some cases, punctal plugs to manage tear drainage.

Treatments aim to lower eye pressure and prevent further optic nerve damage, including eye drops, laser therapy, and surgery.

Age-Related Macular Degeneration (AMD)

AMD affects the macula, the central part of the retina responsible for sharp, detailed vision. The AAO differentiates between dry AMD, the more common form, and wet AMD, which can lead to rapid vision loss. While there is no cure for AMD, treatments can slow its progression, particularly for the wet form. Lifestyle factors, such as a healthy diet rich in antioxidants, are often recommended.
