As we continue to navigate a complex and often polarized world, his words remain a beacon, urging us to look beyond the surface, to question the dominant narratives, and to actively work towards a more equitable and just future. The devil may indeed find work, but Baldwin's legacy equips us with the tools to resist its insidious influence.
