The range of $f(x)$ is the domain of its inverse function, $f^{-1}(x)$, and vice versa. Finding the inverse can be another way to determine the range.

When Algebraic Methods Become Complex

For highly complex or transcendental functions (like trigonometric, exponential, or logarithmic functions with intricate compositions), the algebraic isolation of x might become extremely difficult or even impossible.
