A case study involves an in-depth examination of a bounded system, such as an individual, group, event, or organization. Creswell emphasizes that case studies are characterized by detailed data collection, using multiple sources of information, including interviews, observations, documents, and archival records. The researcher aims to provide a rich, detailed description and analysis of the case, exploring its complexity and context. The "boundedness" of the case is crucial – it must be clearly defined. This approach is effective for exploring unique situations or for providing detailed insights into a specific phenomenon. Examples include studying the implementation of a new educational policy in a particular school, the functioning of a non-profit organization, or the decision-making process of a specific committee.
