signing process and the identity of the signatory, not the truthfulness or accuracy of the document's contents. The responsibility for the content rests solely with the person who made the declaration or affidavit.

4. **Witness Documents if there is a Conflict of Interest:** JPs must decline to witness a document if they have a personal interest in the matter or if they know the signatory well, as this could compromise their impartiality.

Adhering to these limitations is crucial for maintaining the integrity of the JP system and ensuring public trust. Breaching these boundaries can have serious consequences for the JP and the validity of the documents they have witnessed.

Maintaining Impartiality and Confidentiality

The effectiveness of a Justice of the Peace relies heavily on their ability to remain impartial and uphold confidentiality.

The Importance of Impartiality

Impartiality means that a JP must not favour one party over another.
