Renormalization is a remarkable triumph of mathematical ingenuity, allowing QFT to make predictions with unprecedented accuracy. However, the amount of CP violation predicted by the Standard Model is far too small to account for the observed matter-antimatter asymmetry. This implies that there must be other sources of CP violation, or fundamentally new

particles and interactions beyond the Standard Model, that are responsible for this cosmic imbalance. Exploring these avenues is crucial for understanding why our universe is made of matter at all.
