The legacy of Donald Neilson, the Black Panther, is therefore not solely defined by his atrocities, but also by the subsequent improvements in security and the ongoing commitment to ensuring the safety of the Australian populace. His crimes, while horrific, ultimately contributed to a more robust and responsive criminal justice system.
