The development of aural skills, rhythmic understanding, and tonal awareness through his patterned approach provides a strong foundation for instrumental and vocal instruction. Educators who embrace Gordon's philosophy often report students who are more engaged, more musically expressive, and possess a deeper understanding of musical concepts.

Furthermore, Gordon's work provides a framework for understanding and addressing individual differences in musical learning. By recognizing that students develop at different paces and possess varying degrees of musical aptitude, educators can implement differentiated instruction that caters to diverse needs. This inclusive approach ensures that all students, regardless of their perceived talent, have the opportunity to develop their musical potential. The legacy of Edwin E. Gordon continues to inspire and inform contemporary music education, offering a pathway to cultivate not just performers, but truly musically literate and appreciative individuals.
