In some proofs, simply assuming $P(k)$ is true isn't enough to prove $P(k+1)$. You might need to assume that $P(i)$ is true for **all** integers i from the base case up to k . This is known as **strong induction** or the **principle of strong induction**. The structure is similar:

1. **Base Case:** Prove $P(n_0)$ is true.

2. **Inductive Hypothesis (Strong):** Assume $P(i)$ is true for all integers i such that $n_0 \leq i \leq k$, for some arbitrary integer $k \geq n_0$.
3. **Inductive Proof:** Prove that $P(k+1)$ is true, using the assumption that $P(i)$ is true for any i in the range $[n_0, k]$.

Strong induction is particularly useful for problems involving sequences, recurrence relations, and number theory, where properties might depend on multiple preceding terms.

Starting at a Different Integer

As mentioned, not all induction proofs start at $n=1$. If a statement is only meaningful or true for $n \geq m$ (where m is some integer), the base case should be $P(m)$, and the inductive step assumes $P(k)$ for $k \geq m$ and proves $P(k+1)$.

Common Pitfalls and Tips for Success

1. **Clearly State $P(n)$:** Before you begin, write down precisely what you are proving.
2. **Distinguish Between Hypothesis and Proof:** Don't try to prove your inductive hypothesis. It's an assumption used to bridge the gap.
