Some students may struggle to project this confidence, either due to a lack of familiarity with academic discourse or a fear of expressing their own ideas. Instructors encourage students to develop their own unique voice while maintaining an objective and scholarly tone. This involves learning to make clear assertions, defend them rigorously, and engage with counterarguments respectfully.
