The Pickands-Balkema-de Haan theorem states that for a wide class of underlying distributions, the distribution of exceedances over a high threshold converges to a GPD. The GPD, like the GEV, has a shape parameter that governs the tail behavior, allowing it to model different types of extreme events.
