The emphasis on melodic hooks, clear lyrical narratives, and memorable choruses can be traced back to the songs that poured out of those offices. The business of music, too, owes a debt to Tin Pan Alley's pioneering publishers, who established many of the foundational practices of music licensing, royalties, and artist development.
