Building on the momentum of the August Decrees, the National Assembly embarked on its most enduring achievement: the creation of the **Declaration of the Rights of Man and of the Citizen**, adopted on August 26, 1789. This foundational document, inspired by Enlightenment philosophy and the American Declaration of Independence, articulated universal principles of liberty, equality, and fraternity. It proclaimed that all men are born and remain free and equal in rights, defining these rights as liberty, property, security, and resistance to oppression.

The Declaration asserted fundamental freedoms such as freedom of speech, the press, and religion. It established the principle of the separation of powers, the presumption of innocence, and the right to a fair trial. Crucially, it declared that sovereignty resides in the nation, thereby cementing the legitimacy of the National Assembly and its revolutionary endeavors. The Declaration of the Rights of Man and of the Citizen was not just a French document; it was intended as a universal manifesto, a blueprint for a just and free society that would inspire movements for liberty and self-determination across the world. Its

influence on subsequent constitutions and human rights declarations is undeniable.

The Constitutional Monarchy and Growing Divisions

The National Assembly then turned its attention to crafting a new constitution. The initial vision was a constitutional monarchy, where the King would retain some executive power but be subject to the law and the will of the elected legislature. The Constitution of 1791 established this framework, limiting the King's powers and creating a unicameral Legislative Assembly. However, this phase was marked by growing internal divisions within the revolutionary movement and increasing popular radicalization.

Disagreements arose over the extent of suffrage, the role of the Church, and the King's perceived intransigence. Louis XVI's failed attempt to flee France in June 1791 (the Flight to Varennes) severely damaged his credibility and fueled republican sentiments. The National Assembly, grappling with these challenges, also faced external threats as European monarchies grew increasingly alarmed by the revolution's spread. The declaration of war against Austria in April 1792 further intensified the revolutionary climate.

The Legacy of the National Assembly: A Transformative Force

The National Assembly's tenure, though fraught with challenges and ultimately giving way to more radical phases of the revolution, was undeniably transformative. It achieved several critical objectives:

1. **Undermining Absolutism:** It successfully challenged and ultimately dismantled the foundations of absolute monarchy, asserting the principle of popular sovereignty.
2. **Abolishing Feudalism:** The August Decrees eradicated centuries of entrenched privilege and seigniorial rights, paving the way for a more equitable society.
3. **Establishing Fundamental Rights:** The Declaration of the Rights of Man and of the Citizen provided a timeless articulation of human rights and freedoms that continues to inspire.
4. **Creating a Constitutional Framework:** While the Constitution of 1791 was short-lived, it represented a significant step towards a more representative form of government.
5. **National Unity:** It fostered a sense of national identity and purpose, uniting the French people under a common banner of liberty and reform.

The National Assembly, in its various incarnations (from the Constituent Assembly, which drafted the constitution, to the Legislative Assembly), was the engine of the initial, more moderate phase of the French Revolution. Its actions laid the groundwork for the radical changes that followed, including the abolition of the monarchy and the Reign of Terror. However, without the courage and vision of the deputies who declared themselves the National Assembly on June 17, 1789, and their unwavering commitment at the Tennis Court, the subsequent course of French and world history would undoubtedly have been different.

The legacy of the National Assembly serves as a powerful reminder of the transformative potential of collective action, the enduring power of ideas, and the often-turbulent path from entrenched privilege to the pursuit of liberty and equality. Its story remains a crucial chapter in the ongoing narrative of

democratic aspirations and the struggle for self-determination.
