This concept of "competent judges" – individuals who have experienced a wide range of pleasures and are thus best qualified to assess their quality – became a cornerstone of his argument.

The Role of Consequences and Motives

Instead, he proposed that humanity has, over time, developed general rules and principles (such as those concerning justice and honesty) that, when followed, generally lead to the greatest happiness. These secondary principles act as reliable guides for conduct, and it is only in rare or complex situations that a direct appeal to the principle of utility is necessary.

The "Is-Ought" Problem

Mill also faced the challenge of the "is-ought" problem, famously articulated by David Hume, which questions how one can logically derive moral imperatives (oughts) from factual statements (ises). Mill's response was to argue that the desire for happiness is a fundamental and observable fact about human nature. Therefore, the statement that happiness is desirable is not a logical deduction but a statement of fact about what humans inherently seek. He believed that the ultimate sanction for morality lies in the individual's desire for happiness and the social desire for the welfare of the community.

The Enduring Legacy of Mill's Moral Philosophy

John Stuart Mill's moral philosophy remains remarkably relevant today, influencing fields from political theory to economics and environmental ethics. His emphasis on individual liberty, the importance of diverse perspectives, and the pursuit of a meaningful and fulfilling life continue to inform contemporary discussions.

Mill's advocacy for individual liberty and his harm principle have had a profound impact on liberal political thought and continue to shape debates about freedom of speech,

censorship, and government intervention. His arguments for the importance of representative government and the need to protect minority rights are also foundational to modern democratic societies. The concept of a flourishing society requiring a balance between individual freedoms and collective well-being is a direct legacy of his work.

Applications in Ethics and Social Issues

Beyond politics, Mill's ethical framework offers valuable insights into a wide range of contemporary issues. His qualitative distinction of pleasures can be applied to discussions about consumerism, the pursuit of artificial happiness versus genuine fulfillment, and the importance of education and culture.
