6. **Block 15: Military Knowledge:** Evaluates understanding of naval customs, history, regulations, and technical expertise.
7. **Block 16: Sailors and Their Families:** Addresses the sailor's commitment to the well-being of their

shipmates and their families.

8. **Block 17: Professionalism and Integrity:** Focuses on ethical conduct, accountability, and dedication.
9. **Block 18: Command/Indoctrination:** Assesses how well the sailor embodies the command's ethos and contributes to its mission.
10. **Block 19-25: Space for Comments:** Detailed narrative comments, providing context and specific examples for the summary group and individual blocks. This is where the bulk of the qualitative assessment lies.
11. **Block 26-27: Remarks of the Member:** The sailor's opportunity to provide their perspective, acknowledge comments, or offer mitigating circumstances.

Officer Fitness Report (FITREP) Components:

FITREPs share many similarities with EVALs but are tailored to the responsibilities and expectations of commissioned officers. Key sections often include:

1. **Personal Data:** Similar to EVALs, containing essential information.
2. **Summary Group:** A comparative ranking of the officer against their peers.
3. **Qualitative Categories:** These typically cover areas such as Leadership, Professionalism, Military Bearing, and Performance of Duty.
4. **Command Climate:** Assesses the officer's contribution

to a positive and effective command environment.

5. **Professional Development:** Evaluates the officer's commitment to their own growth and the development of their subordinates.
6. **Narrative Comments:** This is the most significant part of a FITREP, providing detailed accounts of accomplishments, leadership examples, and areas for growth.

Key Principles for Effective EVAL and FITREP Writing

Writing a compelling and accurate EVAL or FITREP requires a strategic approach. Here are some fundamental principles to guide you:

1. Be Specific and Provide Evidence:

Vague statements like "excellent performer" or "needs improvement" are unhelpful. Instead, use action verbs and quantify achievements whenever possible. For example:

1. **Instead of:** "Good leader."
2. **Use:** "Led a team of 5 sailors in completing Project Alpha 15% ahead of schedule, exceeding quality benchmarks and receiving commendation from the XO."
3. **Instead of:** "Needs to improve technical skills."
4. **Use:** "Demonstrated a foundational understanding of [specific system], but requires further proficiency in

advanced troubleshooting techniques to fully meet the demands of the [specific role]."

2. Focus on Accomplishments and Impact:

Highlight what the individual has **achieved** and the positive **impact** of their contributions. Think about how their actions benefited the command, mission, or shipmates. Did they save resources? Improve efficiency? Enhance safety? Mentor junior personnel effectively?

3. Use Strong Action Verbs:

Employ a robust vocabulary of action verbs to describe performance vividly. Examples include:

1. **Leadership:** Led, managed, motivated, mentored, guided, developed, inspired, delegated, coached.
2. **Technical Proficiency:** Operated, maintained, repaired, troubleshooted, designed, implemented, analyzed, diagnosed.
3. **Initiative:** Initiated, developed, proposed, created, implemented, pioneered, innovated.
4. **Communication:** Briefed, presented, reported, advised, explained, communicated, documented.

4. Tailor Comments to the Individual's Rank and Responsibilities:

An EVAL for an E-3 will naturally focus on different aspects than one for an E-7. Similarly, a junior officer's FITREP will

differ from a department head's. Ensure your comments reflect the expected competencies and developmental trajectory for their current paygrade and billet.

5. Maintain Objectivity and Fairness:

While highlighting strengths, it's also essential to provide constructive feedback on areas for improvement. This feedback should be balanced, fair, and actionable, offering concrete steps for development rather than vague criticisms. Avoid personal opinions or biases; focus solely on observed performance and behavior.

6. Be Concise and Clear:

Naval personnel are busy. Your evaluations should be easy to read and understand. Avoid jargon where possible, or explain it if necessary. Get straight to the point, but don't sacrifice detail for brevity.

7. Understand the Summary Group Ratings:

The Summary Group rating (e.g., "Far exceeded," "Promotes," "Must Promote") is a critical indicator of a sailor's potential. This rating should be well-supported by the narrative comments. If you rate someone highly, your comments must unequivocally demonstrate why they deserve that rating. Conversely, if improvement is needed, the comments should clearly articulate the issues and suggest a path forward.

8. Proofread Meticulously:

Typos, grammatical errors, and inconsistencies undermine the credibility of your evaluation. Always proofread carefully, and ideally, have another qualified individual review your work before submission. This is a professional document, and professionalism extends to its presentation.

Navigating Common Pitfalls in EVAL and FITREP Writing

Even experienced leaders can fall into common traps when writing evaluations. Being aware of these pitfalls can help you avoid them:

The "One Size Fits All" Approach:

Using generic phrases or templates for every sailor is a disservice to individuals and the system. Each report should be personalized and reflect unique contributions.

The "Recency Effect":

Focusing too heavily on events that occurred only at the end of the reporting period. While recent achievements are important, the entire period of performance should be considered.

The "Halo/Horns Effect":

Allowing a single outstanding trait (halo) or a significant flaw (horns) to disproportionately influence the entire evaluation, overshadowing other aspects of performance.

Lack of Documentation:

Failing to keep regular notes on subordinate performance throughout the reporting period. This leads to reliance on memory, which can be unreliable and lead to incomplete or inaccurate evaluations.

Confusing Potential with Performance:

While potential is important for advancement, the EVAL and FITREP should primarily focus on *demonstrated* performance during the reporting period. Future potential should be addressed thoughtfully and supported by current achievements.

Failure to Provide Constructive Feedback:

Avoiding difficult conversations about areas needing improvement. This can stunt a sailor's growth and lead to recurring issues. Constructive feedback, delivered professionally, is a sign of strong leadership.

Best Practices for Writers and Reviewers

For EVAL/FITREP Writers:

1. **Maintain a Performance Log:** Keep a running document throughout the reporting period, noting achievements, challenges, and areas of observation for each subordinate.
2. **Seek Clarification:** If unsure about specific rating guidelines or requirements, consult your chain of command, your command's administrative office, or relevant Navy instructions (e.g., NAVPERS 1610/2).
3. **Emphasize Impact:** Always ask yourself: "So what?" What was the tangible outcome or benefit of this sailor's action?
4. **Be Honest and Fair:** Your primary responsibility is to accurately reflect performance.

For Reviewers and OICs/COs:

1. **Review for Consistency:** Ensure comments align with the summary group and individual block ratings.
2. **Check for Clarity and Specificity:** Are the comments easy to understand and supported by evidence?
3. **Verify Objectivity:** Remove any language that could be perceived as biased or unprofessional.
4. **Confirm Accuracy:** Ensure all factual information is correct.

The Sailor's Role: Understanding Your EVAL and FITREP

While this guide focuses on writing, it's also crucial for sailors to understand their role in the process. This includes:

1. **Proactive Engagement:** Regularly discuss performance and career goals with your supervisor throughout the year, not just when an evaluation is due.
2. **Accurate Self-Reporting:** Be prepared to provide your supervisor with a well-documented summary of your accomplishments and contributions.
3. **Thoughtful Comments:** Utilize Block 26-27 (or equivalent) to acknowledge comments, provide context, or offer mitigating information, maintaining a professional tone.
4. **Seeking Feedback:** If you receive an evaluation with areas for improvement, actively seek guidance on how to address them.
