While his initial public statements were more reserved, reflecting the political climate of the time, his private writings and later actions would reveal a growing opposition to the institution.

A significant event during his legislative career was his co-sponsorship of a resolution protesting the annexation of Texas, which he viewed as a move to expand the territory of slave states. This early political stand, though not as vociferous as his later pronouncements, signaled his discomfort with the expansion of slavery.
