$$F_{g,\text{perp}} \approx 42.43 \text{ N}$$

Since there is no acceleration perpendicular to the incline, the normal force is:

$$F_N = F_{g,\text{perp}} \approx 42.43 \text{ N}$$

As you can see, the normal force is less than the object's weight (49 N), a direct consequence of the incline reducing the effective force pressing the

object into the surface.

The normal force on an incline is a vector quantity whose magnitude is determined by the object's weight and the angle of the incline, specifically through the cosine of that angle.
