Once you're comfortable with the basic standing figure, you can expand your skills to tackle various poses and perspectives.

Dynamic Poses

For action poses, emphasize the gesture line and exaggerate the curves to convey movement. Think about foreshortening, where objects appear shorter when viewed at an angle. This is achieved by drawing shapes smaller and more compressed.

From Different Angles (Perspective)

When drawing a figure from above or below, the proportions will change. You'll need to apply perspective principles. For instance, when viewed from above, the torso might appear shorter and wider, and the legs longer. When drawing from the side, you'll see the profile of the body more clearly.

Using ellipses for rounded forms like the rib cage and pelvis becomes crucial when drawing from these different angles to maintain a sense of three-dimensionality.

Drawing the Back View

The back view presents its own set of challenges and opportunities. Key features to focus on include:

1. **Scapulae (Shoulder Blades):** Their position and movement are critical.
2. **Spine:** The curve of the spine is highly visible.
3. **Gluteal Muscles:** The shape of the buttocks.
4. **Calves:** Often more prominent from the back.

Remember that many of the same underlying bone structures and muscle groups are present; they are just viewed from a different perspective.

Shading and Rendering the Human Body

Shading is what brings your drawing to life, giving it form, volume, and realism. Understanding light and shadow is paramount.

Understanding Light Source

Identify where your light source is coming from. This will determine which parts of the body are illuminated and which are in shadow. Areas facing the light will be lighter, while those turned away will be darker.

Creating Tones

Use your softer pencils (2B, 4B) to build up darker tones. Layering your pencil strokes can create subtle gradations of light and shadow. A kneaded eraser is excellent for lifting graphite to create highlights or soften transitions.

Form and Volume

Observe how light wraps around curved surfaces. This creates soft transitions between light and shadow, indicating the roundness of muscles and

body parts. Avoid using harsh, flat outlines; instead, let your shading define the edges of the form.

Rendering Muscles

When rendering muscles, think about their shape and how they bulge and taper. Muscles are not isolated forms but flow into each other. Use shading to emphasize these transitions and create a sense of tension or relaxation in the body.

Common Mistakes and How to Avoid Them

Even experienced artists make mistakes, but being aware of common pitfalls can help you improve faster.

1. **Incorrect Proportions:** Always double-check your head-to-body ratio and the relative lengths of limbs. Using a ruler or measuring with your pencil can help.
2. **"Stick Figures":** Neglecting to add volume and weight to the body. Remember to draw in three dimensions.
3. **Stiff or Lifeless Poses:** Forgetting the gesture line. A drawing without a clear gesture often feels rigid.

4. **Ignoring Anatomy:** Drawing only what you see on the surface without understanding the underlying structure. Even simplified drawings benefit from anatomical awareness.
5. **Overworking the Drawing:** Sometimes, less is more. Don't be afraid to let your lines breathe.
6. **Lack of Practice:** Drawing the human body is a skill that requires consistent effort. Draw regularly!

The most crucial advice for learning how to draw a body is to practice consistently. Dedicate time each week to figure drawing. Don't be discouraged by early results; every line you draw is a step forward.
