However, they can also exert "social control," imposing expectations or judgments that may either aid or hinder the individual's management efforts. Understanding this dynamic is vital for tailoring interventions that leverage positive social influences while mitigating negative ones.

8. The Role of the Caregiver

Corbin and Strauss recognized that chronic illness rarely affects just one person. Caregivers, often family members, are deeply involved in the illness trajectory, undertaking significant work themselves. Their experiences, challenges, and needs are integral to the overall picture of chronic illness management. The framework implicitly calls for attention to the caregiver burden and the provision of support for those who provide care.
