Shifting the focus from individual actions and their consequences or adherence to rules, **virtue ethics**, championed by ancient Greek philosophers like Aristotle, emphasizes the cultivation of good character traits, or virtues. Instead of asking "What is the right thing to do?", virtue ethics asks "What kind of person should I be?" Virtues such as honesty, courage, compassion, justice, and temperance are seen as essential for living a flourishing life, or **eudaimonia**. A virtuous person, according to this perspective, will naturally act in morally upright ways.

This approach is less about specific rules and more about developing practical wisdom (**phronesis**) to discern the appropriate course of action in various situations. While virtue ethics offers a compelling vision of moral development, it can sometimes be criticized for not providing clear guidance in specific moral dilemmas, leaving individuals to rely on their developed character, which may vary.

Other Significant Ethical Theories

Beyond these major schools, other important ethical perspectives contribute to our understanding:

1. **Contractarianism/Social Contract Theory:** Proposes that moral principles are those that rational individuals would agree to in a hypothetical social contract to govern their interactions. Philosophers like Thomas Hobbes and John Rawls are associated with this tradition.
2. **Ethics of Care:** Emphasizes the importance of relationships, empathy, and compassion in moral decision-making, often highlighting the distinctiveness of women's moral experiences. Carol Gilligan's work is seminal here.
3. **Feminist Ethics:** Critiques traditional ethical theories for their androcentric biases and seeks to develop ethics that are more inclusive and responsive to the concerns of women and marginalized groups.
4. **Existentialism:** Stresses individual freedom, responsibility, and the subjective creation of meaning. For existentialists like Jean-Paul Sartre, individuals are condemned to be free and must create their own values in a world without

inherent meaning.

1. **Emotivism:** Argues that moral statements are merely expressions of emotion or attitudes (e.g., "Murder is wrong" means "Boo to murder!").

3. **Moral Relativism:** Holds that moral truths are relative to individuals, cultures, or historical periods. There are no universal moral standards.
4. **Moral Nihilism:** Asserts that nothing is morally right or wrong, and that moral values are baseless.

Cognitivism vs. Non-Cognitivism

This distinction relates to whether moral judgments express beliefs that can be true or false (cognitivism) or whether they express something else, like emotions or commands (non-cognitivism). Most realists are cognitivists, while emotivists and prescriptivists are non-cognitivists.
