"Where do you see yourself in 5 years?"

Demonstrate ambition and a desire for growth, but keep it realistic and aligned with the potential career paths within the company. Focus on developing your skills and taking on more responsibility.

6. "Why are you leaving your current/previous job?"

Be positive and professional. Focus on seeking new challenges, opportunities for growth, or a better alignment with your career aspirations. Avoid speaking negatively about former employers or colleagues.

7. "How do you handle pressure/stress?"

Describe your coping mechanisms. Do you prioritize tasks, delegate, take short breaks, or practice mindfulness? Providing a calm and organized approach is key.

Mark of a Top Candidate

What to Ask:

4. **About Success Metrics:** "How is success measured in this role?"

Questions to Avoid:

1. **Salary/Benefits Too Early:** Unless initiated by the interviewer, save these discussions for later stages.
2. **Questions Easily Found Online:** This shows a lack of preparation.
3. **Overly Personal Questions:** Keep it professional.
