The marriage of Mary to her cousin, Henry Stuart, Lord Darnley, in 1565, was a disastrous union. Darnley was vain, impetuous, and ultimately a liability. He proved to be an ineffective consort and a dangerous enemy, particularly to Mary's close advisors.
