The smooth, gleaming white casing stones that once covered the pyramids, made of highly polished Tura limestone, are now largely gone, having been removed over millennia for building materials. Only a few remain at the base of some structures. This loss has obscured the original

intended appearance of the pyramids, which would have been far more dazzling and reflective. Reconstructing their original grandeur is a significant challenge, and understanding the methods used to polish and fit these stones with such precision remains a testament to their advanced craftsmanship. The missing casing stones represent a literal and metaphorical loss of a significant part of the pyramids' secrets.
