This adaptation leans heavily into the melodrama and visual style of classic Hollywood noir, with Crawford delivering a powerful performance that cemented Mildred's image as a tragic, formidable matriarch. The film, while a commercial and critical success, takes certain liberties with the novel, softening some of the darker edges and emphasizing the melodrama.

Much later, Todd Haynes's 2011 HBO miniseries, starring Kate Winslet, offered a more expansive and psychologically nuanced interpretation. This adaptation stays closer to Cain's original text, exploring the complexities of Mildred's relationship with Veda with a raw intensity. Winslet's portrayal of Mildred is less the glamorous victim of the film and more a woman grappling with her own compromises and the devastating consequences of her choices.

Haynes's version is a testament to the novel's continued relevance, delving deeper into the psychological motivations and societal critiques that Cain so expertly laid out.
