This section is where the therapist synthesizes the information and forms clinical judgments. Examples include:

1. Client appears to be experiencing moderate levels of generalized anxiety, exacerbated by situational stressors.
2. Observed cognitive distortions around self-worth are contributing to feelings of depression.
3. Client demonstrates increasing insight into the impact of early childhood experiences on current

relationships.

4. The observed increase in agitation may indicate a temporary exacerbation of underlying trauma-related symptoms.

Plan (P)

This outlines the proposed course of action for future sessions. It includes specific interventions to be used, homework assignments, referrals, or any other steps planned to address the client's goals. It should be directly linked to the assessment. Examples include:

1. Continue exploring cognitive distortions related to self-worth using CBT techniques.
2. Assign client to practice mindfulness exercises daily for stress reduction.
3. Schedule a follow-up appointment for next week to review progress on anxiety management.
4. Refer client to a support group for individuals who have experienced childhood trauma.
5. Collaborate with the client to develop coping strategies for managing interpersonal conflicts.

Therapist's Signature and Credentials
