A natural 20 on a death saving throw brings them back to 1 HP, and a natural 1 counts as two failures. This mechanic adds a tense element to combat, emphasizing the perilous nature of adventuring.

Skill Checks: Navigating the World

Skill checks are the primary mechanism for resolving actions outside of combat that aren't directly tied to attacks or saving throws. These might include climbing a sheer cliff (Athletics), deciphering an ancient rune (Investigation), charming a shopkeeper (Persuasion), or remembering a historical fact (History). The process is identical to other d20 rolls: roll a d20, add the relevant ability modifier, and add proficiency if applicable. The DM sets the DC, and the outcome determines the success or failure of the character's attempt to interact with the world.

Perception and Investigation: Uncovering Secrets

Perception and Investigation are two vital skills that allow characters to discover hidden dangers, secret passages, and crucial clues. Perception checks are often made passively based on a character's Perception score, allowing the DM to discreetly inform them of what they notice. Active Perception checks are used when a character is actively searching an area. Investigation, on the other hand, is more about deduction and piecing together information. These skills are paramount for any

adventuring party seeking to unravel mysteries.

Social Interaction: The Art of Persuasion and Deception

D&D characters are not just warriors; they are also diplomats, negotiators, and tricksters. Skills like Persuasion, Deception, Intimidation, and Insight allow characters to interact with non-player characters (NPCs) in meaningful ways. Persuasion can sway opinions, Deception can mask intentions, Intimidation can cow adversaries, and Insight can reveal the true feelings of others. These social encounters are often resolved through skill checks, with the DM adjudicating the outcomes based on the player's choices and dice rolls.

Magic: The Arcane and Divine Arts
