(Independent clauses: 'She loved the movie' and 'her brother thought it was boring'. Dependent clause: 'because it was too slow'.)**

When to Use Compound-Complex Sentences:

*** To express multiple interrelated ideas with different levels of importance. * To create a sophisticated narrative or argument. * To showcase a complex relationship between events or concepts. * To add richness and depth to your writing, but use them judiciously to maintain clarity.**
