When offered as part of the funeral observance, it provides a structured liturgical rhythm that offers comfort and spiritual grounding.

The Role of Evening Prayer in the Funeral Context

spiritual dimension. As the day draws to a close, this ancient liturgy provides a sacred space for reflection on the day's events and on the broader journey of life and death.
