While new techniques and sophisticated algorithms have emerged, they often represent extensions or refinements of the core quantitative approaches laid out in their work. The ability to understand seismic wave behavior, characterize earthquake sources, and infer Earth structure quantitatively is as critical today as it was when they first articulated these concepts.

Looking Ahead: The Future of Quantitative Seismology

The field of quantitative seismology continues to evolve. With advancements in machine learning and artificial intelligence, new avenues are opening for pattern recognition and data analysis in seismic records. However, these new tools are most effective when guided by a deep understanding of the underlying physics, a deep understanding that Aki and Richards so eloquently provided.
