Despite these arduous conditions, Bahá'u'lláh revealed a vast body of sacred writings – the Kitáb-i-Aqdas (Most Holy Book), the Kitáb-i-Íqán (Book of Certitude), and numerous other tablets and epistles. These writings outline the principles of the Bahá'í Faith, including the independent investigation of truth, the abolition of all forms of prejudice, the equality of men and women, the harmony of science and religion, universal education, the establishment of a world commonwealth, and the need for a spiritual transformation of humanity.

## The Covenant and Succession

Before his passing in 1892, Bahá'u'lláh established a Covenant, appointing his eldest son, ‘Abdu'l-Bahá, as his successor and the authoritative interpreter of his teachings. This ensured the continuity and unity of the Faith, preventing schisms and guiding its development.

# **‘Abdu'l-Bahá: The Exemplar of Bahá’í Life**

‘Abdu'l-Bahá (meaning "Servant of Bahá") served as the Center of the Bahá’í Covenant and the appointed interpreter of Bahá’u'lláh's teachings. His life was one of unwavering service, profound wisdom, and tireless dedication to the cause of human unity.

He also laid the groundwork for the establishment of the Universal House of Justice, the supreme governing body of the Bahá’í Faith, which was later elected in 1963.

Upon Shoghi Effendi's passing in 1957, the guardianship of the Faith passed to the Hands of the Cause of God, who then elected the first Universal House of Justice in 1963.

The Universal House of Justice, headquartered at the Bahá'í World Centre in Haifa, is the supreme legislative and administrative body of the Bahá'í Faith. Its members are elected every five years by the members of National Spiritual Assemblies. The Universal House of Justice is responsible for interpreting Bahá'í law, guiding the global Bahá'í community, and implementing Bahá'u'lláh's vision for a peaceful and just world. Its decisions are authoritative for all Bahá'ís worldwide.
