this problematic approach, where the focus was on collecting and preserving Indigenous cultures deemed to be 'dying' under the weight of Western civilization, rather than empowering them to thrive.

Linda Tuhiwai Smith's Framework: A Paradigm Shift

Linda Tuhiwai Smith, a Māori scholar, provides a critical and comprehensive framework for understanding and dismantling the colonial legacies embedded within research practices. Her book, *Decolonizing Methodologies*, is a cornerstone for anyone seeking to engage in research that is ethical, respectful, and empowering for Indigenous peoples. Smith argues that decolonizing research is not simply about adding an Indigenous perspective; it is about fundamentally rethinking the power dynamics, methodologies, and purposes of research itself.
