$$v_{bif} = 6.0 \text{ kg}\cdot\text{m/s} / 0.5 \text{ kg}$$

$$v_{bif} = +12.0 \text{ m/s}$$

The velocity of the billiard ball after the collision is +12.0 m/s. It moves in the same direction as the bowling ball was initially traveling, which is consistent with the conservation of momentum.
