7. Post-Venipuncture:

2. Withdraw the needle smoothly and at the same angle it was inserted.
3. Immediately apply firm pressure to the puncture site with a clean gauze pad.

5. Dispose of the needle and holder in the sharps container.
6. Mix tubes containing additives by gently inverting them 5-10

times.

7. Label all specimens accurately with the patient's full name, date of birth, collection date and time, and your initials.
8. Ensure the patient is comfortable and has no further bleeding before they leave.

Capillary Puncture: An Alternative Method

For infants, young children, or when only small amounts of blood are needed, capillary puncture (finger stick or heel stick) is employed. This method requires careful technique to obtain a sufficient sample without damaging the delicate tissues.
