5. Take the square root of both sides:
$$x + 3 = \pm\sqrt{4}$$
$$x + 3 = \pm 2$$
6. Isolate x :
$$x = -3 \pm 2$$
7. This gives us two solutions:
$$x_1 = -3 + 2 = -1$$
$$x_2 = -3 - 2 = -5$$

Case 2: Leading Coefficient (a) is Not 1

If the leading coefficient 'a' is not 1, the first step is to divide the entire equation by 'a' to make the leading coefficient 1. This simplifies the process to the steps outlined in Case 1.

Consider the quadratic equation: $ax^2 + bx + c = 0$.

1. **Divide by 'a':**

$$x = 2 \pm 1$$
8. Solutions:
$$x_1 = 2 + 1 = 3$$
$$x_2 = 2 - 1 = 1$$

Case 3: Quadratic Expressions in the form $ax^2 + bx + c$

Completing the square is also used to rewrite quadratic expressions into vertex form, $a(x - h)^2 + k$, which is particularly useful for graphing parabolas and identifying their key features.

Consider the expression: $x^2 + 8x + 10$.

1. **Group the x terms:**

$$(x^2 + 8x) + 10$$

2. **Complete the square within the group:** Half of 8 is 4, and 4^2 is 16. Add and subtract 16 inside the parenthesis to maintain balance.

$$(x^2 + 8x + 16 - 16) + 10$$

3. **Factor the perfect square trinomial:**

$$(x + 4)^2 - 16 + 10$$

4. **Combine the constants:**

$$(x + 4)^2 - 6$$

This expression is now in vertex form. The vertex of the parabola represented by this expression would be at $(-4, -6)$.

Common Pitfalls and How to Avoid Them

5. **Confusing equation solving with expression manipulation:** When solving equations, you must add the completed square term to *both* sides. When rewriting an expression, you must add and subtract the term within the expression itself to maintain equality.
