1. **Mass of the central body:** A more massive central body exerts a stronger gravitational pull, allowing for faster orbital speeds or wider orbits for a given velocity.
2. **Mass of the orbiting body:** While the orbiting body's mass influences the gravitational force, its effect on the orbit itself is less pronounced than the central body's mass, especially when the central body is vastly more massive.
3. **Velocity of the orbiting body:** This is perhaps the most critical factor. Too little velocity, and the object falls into the central body. Too much velocity, and it escapes the gravitational pull. The precise velocity creates a stable orbit.
4. **Distance from the central body:** As dictated by the inverse square law, greater distances result in weaker gravitational forces and slower orbital speeds for stable orbits.

Johannes Kepler, an astronomer in the early 17th century, meticulously analyzed astronomical data and formulated three laws of planetary motion. These laws, derived before Newton's theory of gravity, accurately describe how planets move around the sun. The PhET "Gravity and Orbits" simulation provides an excellent platform to verify and understand Kepler's Laws.

### Kepler's First Law: The Law of Ellipses

**Statement:** The orbit of every planet is an ellipse with the Sun at one of the two foci.

**PhET Simulation Insights:** When you set up a system in the PhET simulation with a central star and a planet, you will observe that the planet's path is rarely a perfect circle. Instead, it traces an elliptical path. The simulation allows you to adjust the initial velocity and position of the planet. By carefully manipulating these parameters, you can create nearly circular orbits, but with slight perturbations or specific initial conditions, the elliptical nature becomes evident. You can often see the planet moving closer to and then further from the central star, a hallmark of an elliptical orbit. The simulation doesn't explicitly mark the foci, but by observing the varying distance from the central body, one can infer the presence of an ellipse.

### Kepler's Second Law: The Law of Equal Areas

**Statement:** A line joining a planet and the Sun sweeps out equal areas during equal intervals of time.

**PhET Simulation Insights:** This law is often the most visually compelling to demonstrate with the PhET simulation. The simulation typically includes tools to measure distances, velocities, and often, area swept by a line connecting the orbiting object to the central body. When you run the simulation, you can observe that the planet moves faster when it's closer to the central star (periapsis) and slower when it's farther away (apoapsis). If you enable the "area sweep" tool, you will see that the area traced by the line from the central star to the planet in a given time interval (e.g., 10 seconds) is the same, regardless of whether the planet is moving fast or slow. This directly illustrates that the planet covers more orbital distance when it's moving faster to compensate for the shorter distance from the central body, thus sweeping out equal areas.

**Analytical Significance:** This law is a direct consequence of the conservation of angular momentum. As the planet gets closer to the central body, its speed increases to maintain the same angular momentum, and vice versa. The PhET simulation provides a tangible way to see this dynamic interplay.

# Kepler's Third Law: The Law of Harmonies

**Statement:** The square of the orbital period of a planet is directly proportional to the cube of the semi-major axis of its orbit.

**PhET Simulation Insights:** This law relates the time it takes for an object to complete an orbit (the period) to the size of its orbit. In the PhET simulation, you can:

1. Set up multiple celestial bodies orbiting a central star at different distances.
2. Measure the orbital period of each body (the time for one full revolution).
3. Measure the semi-major axis of their orbits (for near-circular orbits, this is essentially the radius).

By plotting the square of the period ( $T^2$ ) against the cube of the semi-major axis ( $a^3$ ) for various orbiting bodies, you will observe a linear relationship. This empirical observation in the simulation confirms Kepler's third law. You can also use the simulation's tools to directly calculate the ratio  $T^2/a^3$  for different orbits, and you will find it to be approximately constant for all objects orbiting the same central mass. This proportionality constant is directly related to the mass of the central star, linking Kepler's empirical laws to Newton's gravitational theory.

**Mathematical Connection:** For a circular orbit, Kepler's third law can be derived from Newton's law of gravitation:  $T^2 = \frac{4\pi^2}{GM} a^3$ . The PhET simulation allows users to experimentally verify this relationship without needing to perform complex derivations.

## Common PhET "Gravity and Orbits" Questions and Answers

Educators often use the PhET "Gravity and Orbits" simulation to pose specific questions that test students' understanding of the underlying physics. Here are some common scenarios and their analytical answers:

### Scenario 1: Changing the Mass of the Central Star

**Question:** If you double the mass of the central star while keeping the planet's orbit the same, what happens to the planet's orbital speed?

**PhET Insights & Answer:** Using the simulation, you would observe that the planet's orbital speed increases significantly. Analytically, Newton's law of gravitation ( $F = G \frac{m_1 m_2}{r^2}$ ) shows that force is directly proportional to the mass of the central body ( $m_1$ ). This increased gravitational force provides a larger centripetal force, requiring a higher orbital velocity to maintain the same orbital radius. If you were to derive Kepler's third law from Newton's law for circular orbits ( $T^2 = \frac{4\pi^2}{GM} a^3$ ), you'd see that for a constant semi-major axis ( $a$ ), increasing  $M$  (mass of the central star) would decrease  $T$  (period). A shorter period means a higher orbital speed.

Since the planet's mass is in the denominator of this acceleration equation, doubling the planet's mass means its acceleration due to gravity is unchanged. The orbit is determined by the gravitational pull of the *central body* and the *planet's velocity*, not its own mass (assuming it's much

smaller than the central body).

## Scenario 3: Adjusting Initial Velocity

**Question:** You have a planet in a stable orbit. If you slightly decrease its orbital velocity, what happens?

**PhET Insights & Answer:** The simulation would show the planet spiraling inwards, eventually crashing into the central star. Analytically, a decrease in orbital velocity means the centripetal force provided by gravity is no longer sufficient to maintain the current orbital path. The planet's inertia is now greater than the inward pull of gravity at that speed. As it moves closer, the gravitational force increases, and if the velocity is still too low, it will continue to spiral inwards.

**Question:** What happens if you slightly increase the orbital velocity?

**PhET Insights & Answer:** The simulation would show the planet moving into a wider elliptical orbit, or potentially escaping the central body's gravity altogether if the velocity increase is substantial. Analytically, an increased velocity provides more inertia, causing the planet to want to move in a straighter line. Gravity's pull is overcome to a greater extent, resulting in a larger orbital path. If the velocity is high enough, the kinetic energy will exceed the potential energy, leading to an unbound (hyperbolic) trajectory.

## Scenario 4: Two Orbiting Bodies

**Question:** Set up two equal masses orbiting each other. What do you observe?

**PhET Insights & Answer:** The simulation will show both masses orbiting their common center of mass. Analytically, when two objects are of comparable mass, they both exert significant gravitational influence on each other. Instead of one body orbiting the other, they both orbit a point in space called the barycenter or center of mass. This is a crucial distinction from the simplified scenarios where one mass is overwhelmingly larger than the other.

## Scenario 5: Creating Satellites

**Question:** How can you create a stable orbit for a moon around a planet?

**PhET Insights & Answer:** The key is to provide the moon with the correct tangential velocity at a suitable distance from the planet. The planet's gravity will then act as the centripetal force. The simulation allows you to "play" with the initial velocity of the moon. You'll find that there's a specific range of velocities that result in a stable orbit, and values outside this range will cause the moon to crash into the planet or fly away. This directly relates to the concept of escape velocity and orbital velocity.
