Parametric Estimation

This method uses statistical relationships between historical data and other variables (parameters) to calculate the cost of a project. For example, the cost of a highway project might be estimated based on the number of lanes, length, and terrain type.

Analogous Estimation

Also known as "top-down" estimation, this method uses the actual cost of previous, similar projects as the basis for estimating the cost of a current project. It's often used in the early stages when less information is available but requires significant expert judgment.

Bottom-Up Estimation

This is the most time-consuming but also the most accurate method. It involves estimating the cost of each individual

work package or task within a project and then summing them up to arrive at the total project cost. This is closely aligned with detailed, itemized estimation.
