For points-tested skilled visas (Subclass 189, 190, 491), you first submit an EOI through SkillSelect. If your EOI meets the pass mark and your occupation is in demand, you may receive an invitation to lodge a formal visa application.

6. Visa Application and Payment

Once invited, you will lodge your formal visa application online and pay the relevant visa application charges. Be prepared to provide all supporting documentation at this stage.

7. Health and Character Checks

You and your family members will need to undergo medical examinations by approved panel physicians and provide police certificates to demonstrate good character.
