The echoes of his conscience are a vital guide, urging us to use our words not to obscure, but to illuminate; not to control, but to liberate; and not to conform, but to question. And in doing so, we continue the vital work of holding a mirror up to society, ensuring that the lessons of the past inform a more just and informed future.
