where a molecule cannot be accurately represented by a single Lewis structure, but rather by a hybrid of two or more contributing structures.

In resonance, the electrons are not localized between two specific atoms but are delocalized over a larger part of the molecule. The actual structure of the molecule is a weighted average of these contributing resonance structures. A classic example is the benzene molecule (C_6H_6). While benzene can be drawn with alternating single and double bonds, experimental evidence shows that all C-C bonds in benzene are identical in length and strength. Pauling explained this by proposing that benzene is a resonance hybrid of two Kekulé structures, where the pi electrons are delocalized around the ring. This delocalization contributes significantly to the stability of the benzene molecule.

The concept of resonance, though sometimes challenging for students to grasp, is fundamental to understanding aromaticity, conjugated systems, and the electronic properties of many organic and inorganic compounds. It highlights the limitations of simple localized bonding models and points towards a more nuanced view of electron distribution.

The Impact and Legacy of "The Nature of the Chemical Bond"
