- * **Expressions:** An expression is a combination of terms, constants, and variables, connected by mathematical operations. The left side of an equation (" $2x + 5$ ") is an expression, and the right side (" 11 ") is also an expression.
- * **The Equal Sign (=):** This symbol is crucial. It indicates that the expression on the left is

equivalent to the expression on the right.

The Goal: Solving the Equation

The primary objective when working with an algebraic equation is to **solve** it. Solving an equation means finding the value or values of the variable(s) that make the statement true. These values are called the **solutions** or **roots** of the equation. To solve an equation, we employ a set of logical steps that maintain the equality of both sides. This often involves performing the same operation on both sides of the equation. For instance, if we have " $x + 3 = 7$ ", we can subtract 3 from both sides: $(x + 3) - 3 = 7 - 3$ $x = 4$ In this case, '4' is the solution to the equation.

Types of Algebraic Equations: A Spectrum of Complexity

Algebraic equations can range from simple to highly complex, categorized by the highest power of the variable present.

Linear Equations: The Building Blocks

The most fundamental type is the **linear equation**. In a linear equation, the highest power of the variable is one. They typically take the form " $ax + b = c$ ", where 'a', 'b', and 'c' are constants, and 'a' is not zero. **Definition:** A linear equation is an equation in which each term is either a constant or the product of a constant and a single variable. **Example 1 (One Variable):** Consider the equation: ' $3x - 7 = 14$ ' To solve this:
1. Add 7 to both sides: ' $3x - 7 + 7 = 14 + 7$ ' which simplifies

to $3x = 21$. 2. Divide both sides by 3: $3x / 3 = 21 / 3$ which gives $x = 7$. * **Solution:** $x = 7$. We can verify this by substituting 7 back into the original equation: $3(7) - 7 = 21 - 7 = 14$. The equation holds true. **Example 2 (Two**

Variables): Linear equations can also involve multiple variables. For instance: $2y + 5x = 10$. In this case, there isn't a single unique solution for 'x' and 'y'. Instead, there are infinitely many pairs of (x, y) that satisfy the equation. We often express one variable in terms of the other. For example, to express 'y' in terms of 'x': 1. Subtract $5x$ from both sides: $2y = 10 - 5x$ 2. Divide both sides by 2: $y = (10 - 5x) / 2$ or $y = 5 - (5/2)x$. * This represents a line on a coordinate plane, where every point on the line is a solution.

Quadratic Equations: Introducing the Power of Two

When the highest power of the variable in an equation is two, it's called a **quadratic equation**. These equations have a more complex structure, typically written in the form " $ax^2 + bx + c = 0$ ", where 'a', 'b', and 'c' are constants, and 'a' is not zero. **Definition:** A quadratic equation is a second-degree polynomial equation in a single variable. **Example 1:**

Consider the equation: $x^2 - 5x + 6 = 0$. Solving quadratic equations can be done through various methods: * **Factoring:** We look for two numbers that multiply to 'c' (6) and add up to 'b' (-5). These numbers are -2 and -3. * So, we can factor the equation as: $(x - 2)(x - 3) = 0$. * For this product to be zero, at least one of the factors must be zero. * If $x - 2 = 0$, then $x = 2$. * If $x - 3 = 0$, then $x = 3$. * **Solutions:** $x = 2$ and $x = 3$. * **Quadratic Formula:** For equations in the form $ax^2 + bx + c = 0$, the solutions are given by $x = [-b \pm \sqrt{b^2 -$

$4ac] / 2a$. * In our example: $a = 1$, $b = -5$, $c = 6$. * $x = [5 \pm \sqrt{(-5)^2 - 4 * 1 * 6}] / (2 * 1)$ * $x = [5 \pm \sqrt{25 - 24}] / 2$ * $x = [5 \pm \sqrt{1}] / 2$ * $x = [5 \pm 1] / 2$ * This gives two solutions: $x = (5 + 1) / 2 = 6 / 2 = 3$ and $x = (5 - 1) / 2 = 4 / 2 = 2$. Quadratic equations can have zero, one, or two real solutions.

Higher-Order Polynomial Equations

Equations with variables raised to powers higher than two are called **polynomial equations**. For instance, a cubic equation has the highest power of 3 (e.g., $x^3 + 2x^2 - x + 5 = 0$), and a quartic equation has the highest power of 4 (e.g., $x^4 - 3x^2 + 1 = 0$). As the degree of the polynomial increases, solving these equations generally becomes more challenging, often requiring advanced techniques or numerical approximation methods.

Radical Equations, Exponential Equations, and Logarithmic Equations

Beyond polynomials, algebraic equations can involve other mathematical functions:

* **Radical Equations:** These contain variables within a radical (square root, cube root, etc.), such as $\sqrt{x + 1} = 3$. Solving these often involves isolating the radical and then raising both sides to a power to eliminate the radical.

* **Exponential Equations:** These have variables in the exponents, like $2^x = 8$. Solving them often involves using logarithms.

* **Logarithmic Equations:** These involve logarithms of expressions containing variables, such as $\log_2(x) = 3$. The definition of a logarithm is key to solving these.
