This involves walking by faith, not by sight, and consistently discerning God's will in every situation. The concept of **walking by faith** is a cornerstone here.

The "Walk" principle calls for conscious obedience to God's Word and active participation in the life of the Spirit. This involves:

III. Stand: Resisting the Enemy and Standing Firm

The Role of Defense and Resilience

The final element, "Stand," in Watchman Nee's framework, directly addresses the spiritual opposition believers face. Ephesians 6:10-11, "Finally, be strong in the Lord and in his mighty power. Put on the full armor of God, so that you can take your stand against the devil's schemes," serves as a key biblical anchor for this teaching. "Stand" is about actively resisting the enemy's attacks and maintaining one's ground in faith.

This is not a position of aggression, but one of steadfast resilience. It's about putting on the **full armor of God**, as described by Paul, and refusing to yield to the enemy's temptations, accusations, or deceptions. Watchman Nee taught that when we stand, we stand not in our own strength, but in the strength of God and in the power of His victory, which we have already secured through our "Sit." This highlights the interconnectedness of the three concepts.

The "Stand" principle involves several crucial practices:

1. **Resisting the Devil:** Actively rejecting his lies and temptations. This involves understanding the adversary's tactics, often referred to as **devil's schemes**.

3. **Perseverance in Trials:** Enduring difficulties with faith and hope, knowing that God is with us. This involves cultivating **spiritual resilience**.
4. **Upholding the Gospel:** Defending the truth of the gospel and living a life that testifies to its power.

"Stand" calls for a conscious decision to be unwavering in our commitment to Christ, even when faced with opposition. It's about the spiritual fortitude that comes from knowing who you are in Christ and the power that is at work within you.
