Works like Chrétien de Troyes' romances (*Erec and Enide*, *Cligès*, *Lancelot*, *Yvain*, and *Perceval*) were foundational, establishing key characters and plotlines that would be retold and reinterpreted for centuries. Courtly love, a complex and idealized form of romantic devotion, often involved a knight's passionate, often unrequited, love for a noble lady, emphasizing service, devotion, and refinement of manners. This concept significantly influenced social customs and literary expression, shaping perceptions of gender and relationships.

Chivalry and the Heroic Ideal: Knights and Their Deeds

The figure of the knight, embodied by the ideals of chivalry, loomed large in medieval literature. Chivalry encompassed a code of conduct that valued bravery, loyalty, honor, courtesy, and protection of the weak.
