This means accepting that the 'now' is always already marked by the past and anticipates the future, that identity is never fully present but is always in process. For African and Middle Eastern thinkers, this translates to a more flexible and critical engagement with their own histories and cultural traditions, allowing for innovation and adaptation rather than a rigid adherence to a romanticized past.
