The immense heat generated by radioactive decay within Earth's core and mantle creates slow-moving, convective currents. Hotter, less dense material rises, while cooler, denser material sinks. 3. **Transform Boundaries:** Plates slide past each other horizontally. No new crust is created or destroyed, but the friction between the plates can generate significant earthquakes. The San Andreas Fault in California is a well-known example of a transform boundary.

The interplay of these boundaries explains the geographical distribution of geological phenomena, including the Pacific Ring of Fire, a zone of intense seismic and volcanic activity encircling the Pacific Ocean.

Geodesy: The Precise Measurement of Earth's Movements

While plate tectonic theory provides the conceptual framework, it is geodesy that provides the empirical evidence and quantitative data to support and refine it. Geodesy, derived from the Greek words "geo" (Earth) and "daiesis" (to divide or measure), is the science of accurately determining the shape, size, and orientation of the Earth, as well as the positions of points on its surface, and their changes over time.
