Communication Skills

The ability to clearly present information in reports, or to seek clarification on form requirements, highlights your communication prowess. This includes both written and verbal communication.

Technical Proficiency

Depending on the role, you might be expected to use specific software for creating, managing, or analyzing forms and reports. Interviewers will want to gauge your familiarity with relevant tools.

This answer demonstrates integrity and a proactive approach to preventing future mistakes. Do not blame others.
