Antiques in good condition can be quite valuable, but their FMV depends on current collector trends and what similar pieces are fetching at auction or in antique stores. Be realistic about the current resale market for used furniture, which can be quite competitive.

Electronics and Appliances

Electronics depreciate rapidly. Newer, functional, and in-demand electronics (like recent model flat-screen TVs or laptops) will have a higher FMV than older, bulkier models. Ensure all items are in working order and include all necessary accessories (cords, remotes). Very old electronics may have minimal or no resale value.

Books and Media

While a rare first edition in excellent condition can be valuable, most donated books have a low FMV. Consider the condition, edition, and whether the book is still relevant or sought after. Textbooks may have some value if they are recent editions. CDs, DVDs, and vinyl records are also subject to market demand; older or common titles may have very little resale value.

Art and Collectibles

This category requires the most diligence. Original artwork, signed prints, antique collectibles, and rare items can be worth a significant amount. However, determining their FMV often requires professional appraisal. If you believe an item might be worth more than \$500, the IRS requires a qualified appraisal. Research similar items sold by reputable auction houses or dealers. Be wary of relying solely on online estimates, which can be inaccurate.

Vehicles

Donating a car, truck, boat, or RV has specific rules. If the charity sells the vehicle, your deduction is generally limited to the gross proceeds from the sale. If the charity intends to use the vehicle for its exempt purpose, you may be able to deduct the FMV. For vehicles valued over \$500, the charity must provide you with a written acknowledgment that includes the vehicle identification number, the sale date, and the gross proceeds. Websites like the IRS provide detailed publications on vehicle donations.

When to Seek a Professional Appraisal

The IRS requires a qualified appraisal for donated property if the claimed deduction for that property is more than \$5,000. For non-cash contributions, this threshold can also apply if you donate more than \$500 worth of certain types of property, like closely held stock. A qualified appraiser is an individual or company that meets specific IRS requirements and is recognized for their expertise in valuing certain types of property. The cost of an appraisal is a deductible expense itself, but it's essential to ensure the appraiser is indeed qualified.

Tips for Finding a Qualified Appraiser

1. Look for appraisers affiliated with professional organizations like the American Society of Appraisers (ASA), the Appraisers Association of America (AAA), or the International Society of Appraisers (ISA).
2. Ensure the appraiser has expertise in the specific type of item you are donating.
3. Get a written appraisal report that clearly states the valuation methods used.
4. Understand that the appraiser's fee should be based on their time and expertise, not a percentage of the appraised value.

Record-Keeping: Your Proof of Donation

Meticulous record-keeping is vital for substantiating your charitable contribution deductions. The IRS requires specific documentation depending on the value of your donation:

For Donations Valued at \$250 or More

You must have a contemporaneous written acknowledgment from the charity. This acknowledgment should include:

1. The name of the charitable organization.
2. The date and location of the contribution.
3. A detailed description of the donated property.
4. The fair market value of the property.
5. A statement of whether the organization provided any goods or services in return for the contribution.

For Property Valued Between \$500 and \$5,000

In addition to the acknowledgment described above, you must also file IRS Form 8283, Noncash Charitable Contributions, with your tax return. This form requires more detailed information about the donated property.

For Property Valued Over \$5,000

As mentioned earlier, a qualified appraisal is required, and you must attach Form 8283 to your tax return, along with a copy of the appraisal report.
