OIG Investigations Involving Pharmaceutical Companies: A General Framework

The HHS OIG's investigative purview concerning pharmaceutical companies is broad and often involves collaborations with other federal agencies, such as the Department of Justice (DOJ) and the Food and Drug Administration (FDA). Common areas of OIG investigation include:

Antikickback Statute Violations

One of the most frequently investigated statutes is the Anti-Kickback Statute (AKS). This federal law prohibits offering, paying, soliciting, or receiving remuneration (anything of value) to induce or reward referrals of federal healthcare program business. For pharmaceutical companies, this can manifest in several ways:

1. **Payments to Physicians:** The OIG scrutinizes payments made by pharmaceutical companies to physicians, such as for speaking engagements, consulting fees, or research grants. The concern is whether these payments are legitimate compensation for services or disguised kickbacks to influence prescribing.
2. **Speaker Programs:** Pharmaceutical companies often host speaker programs to educate healthcare professionals about their drugs. The OIG investigates whether these programs are designed to reward physicians for prescribing or recommending their products.
3. **Educational Grants and Donations:** While legitimate, grants and donations to professional organizations or continuing medical education programs can also be investigated if they are perceived as being tied to prescribing patterns.

False Claims Act (FCA) Violations

The False Claims Act is another cornerstone of OIG enforcement. It prohibits knowingly submitting or causing to be submitted false or fraudulent claims to the federal government. In the context of pharmaceuticals, FCA violations can occur through:

1. **Off-Label Promotion:** Promoting a drug for uses not approved by the FDA can lead to FCA liability if federal healthcare programs are billed for these unapproved uses. The OIG works with the DOJ to prosecute such cases.
2. **Defective Drugs:** If a pharmaceutical company knowingly sells defective drugs that are then billed to federal programs, this can constitute a false claim.
3. **Misrepresenting Drug Efficacy or Safety:** Making false claims about a drug's efficacy or safety to secure government contracts or influence prescribing can also trigger FCA investigations.
4. **Pricing Schemes:** Schemes designed to defraud federal programs by manipulating drug prices,

such as through inflated average wholesale prices (AWP) or kickbacks that reduce the net cost to the government, can lead to FCA violations.

Off-Label Marketing and Promotion

While not illegal per se for physicians to prescribe drugs for off-label uses, it is illegal for pharmaceutical companies to actively market or promote their drugs for these unapproved indications. The OIG, in conjunction with the FDA and DOJ, actively investigates allegations of off-label promotion. This can involve scrutinizing marketing materials, sales representative activities, and communications with healthcare professionals. The legal framework here is intricate, and the line between permissible scientific exchange and illegal promotion can be thin, making it a frequent area of contention.

Drug Pricing and Rebates

The pricing of prescription drugs is a perpetual concern for policymakers and oversight bodies. The OIG examines various aspects of drug pricing, including:

1. **Average Manufacturer Price (AMP):** The OIG investigates the accuracy of AMP reporting, which is used to calculate Medicaid drug rebates.
2. **Best Price:** Similarly, accurate reporting of "best price" is crucial for Medicare Part B drug reimbursement and Medicaid rebates.
3. **"Drug Diversion" Schemes:** The OIG may investigate schemes where drugs are diverted from their intended markets to inflate prices or avoid rebate obligations.

Research Integrity and Clinical Trials

The OIG also has a role in ensuring the integrity of pharmaceutical research. This includes:

1. **Data Falsification:** Allegations of falsifying data in clinical trials or misrepresenting research findings can lead to OIG investigations.
2. **Participant Safety:** Ensuring the safety and ethical treatment of participants in clinical trials is also a concern.

Merck & Co., Inc. and OIG Investigations: Past and Present

1. **Voluntary Disclosures:** Companies may proactively disclose potential violations to the OIG through its Self-Disclosure Protocol. This can lead to more favorable resolutions compared to being investigated externally.
2. **Civil Settlements:** Many OIG investigations conclude with civil settlements, where the company agrees to pay a sum of money to resolve allegations without admitting guilt. These settlements are often in the millions or even billions of dollars.
3. **Corporate Integrity Agreements (CIAs):** In many settlement agreements, pharmaceutical companies are required to enter into Corporate Integrity Agreements with the OIG. These are comprehensive, multi-year contracts that mandate specific compliance measures, reporting

requirements, and independent oversight.

The Role of Corporate Integrity Agreements (CIAs)

CIAs are a powerful tool used by the OIG to ensure ongoing compliance. For a company like Merck, a CIA would typically include provisions such as:

1. **Compliance Program Enhancements:** The company must implement or enhance its compliance program, including appointing a compliance officer, establishing a compliance committee, and providing regular training to employees.
2. **Monitoring and Auditing:** The CIA often requires regular audits of the company's operations, including its marketing, sales, and billing practices, by an independent auditor.
3. **Reporting to the OIG:** The company must submit regular reports to the OIG detailing its compliance activities, audit findings, and any corrective actions taken.
4. **Exclusion Provisions:** CIAs usually contain provisions that allow the OIG to exclude the company from federal healthcare programs if it breaches the terms of the agreement.

The existence and terms of any CIA involving Merck would be publicly accessible through the OIG's website, offering transparency into the company's compliance commitments. The rigorous nature of CIAs underscores the OIG's commitment to holding pharmaceutical companies accountable for their actions.
