Today's sawmills utilize sophisticated scanning technology to optimize log breakdown, computer-controlled saws for precision cutting, and advanced material handling systems. Environmental concerns have led to the development of more efficient drying processes, waste wood utilization (e.g., for biomass fuel or composite materials), and a greater emphasis on sustainable forestry certifications.
