For instance, Technetium-99m (^{99m}Tc), with a half-life of about 6 hours, is ideal for many diagnostic procedures, while Iodine-131 (^{131}I), with a longer half-life of 8 days, is used for therapeutic applications like thyroid cancer treatment.

Understanding the relationship between activity, half-life, and time is a cornerstone of safe and effective nuclear medicine practice. This involves calculations with exponential functions and logarithms, essential for any nuclear medicine professional.

Quantifying Radiation: Activity and Dose Calculations

The measurement of radioactivity is fundamental to nuclear medicine. **Activity**, typically measured in Becquerels (Bq) or Curies (Ci), quantifies the rate of radioactive decay in a sample. Technologists must accurately measure and record the activity of radiopharmaceuticals before administration to ensure the correct dose is delivered.

The fundamental equation for internal dose calculation using the MIRD schema is:

Where:

External Dose Calculations and Radiation Protection

Nuclear medicine technologists also deal with external radiation exposure from radioactive sources. This includes handling radioactive materials in the hot lab, preparing doses, and managing patients who have received therapeutic amounts of radionuclides.

The **inverse square law** is a fundamental principle governing external radiation exposure. It states that the intensity of radiation from a point source is inversely proportional to the square of the distance from the source:

Shielding materials, such as lead or concrete, attenuate radiation, and their effectiveness is calculated based on the radionuclide's energy and the material's properties, often involving exponential attenuation formulas. Technologists must understand these principles to select appropriate shielding and ensure safe handling of radioactive materials.

Image Formation and Analysis: The Mathematics of Detection

Gamma Camera Principles

1. **SPECT:** In SPECT, gamma rays are detected from multiple angles as the gamma camera rotates around the patient. This projection data is then processed using algorithms like filtered backprojection or iterative reconstruction to create 3D images. These algorithms involve principles of Fourier transforms and Radon transforms, which are complex mathematical tools for analyzing and reconstructing data from projections.
2. **PET:** PET imaging relies on detecting pairs of annihilation photons emitted from the decay of positron-emitting radionuclides. The scanner records the coincidence of

these photon pairs, which provides information about the line along which the annihilation occurred. Algorithms like filtered backprojection, maximum likelihood expectation maximization (MLEM), and ordered-subset expectation maximization (OSEM) are used to reconstruct the distribution of the radiotracer from this coincidence data. These algorithms involve solving large systems of linear equations and statistical modeling to account for factors like attenuation, scatter, and random coincidences.

The quality of these reconstructed images is directly dependent on the mathematical sophistication of the algorithms used, as well as the underlying physics of radiation detection and interaction with matter. Technologists must understand how these algorithms work to optimize imaging protocols, troubleshoot image artifacts, and interpret the resulting data accurately.

Quantitative Imaging and Dose Management

Beyond qualitative assessment, nuclear medicine increasingly employs **quantitative imaging** to extract precise numerical data about radiotracer uptake and distribution. This involves more advanced mathematical modeling to correct for various physical factors that can affect the measured activity.

For example, in PET imaging, corrections for photon attenuation (where gamma rays are absorbed by the body) and scatter (where gamma rays change direction) are essential for accurate quantification. These corrections are implemented using mathematical models and iterative reconstruction algorithms. Similarly, blood flow and metabolic rate can be quantified by analyzing the time-activity curves of radiotracers in specific regions of interest, requiring curve fitting and pharmacokinetic modeling.

This quantitative data is invaluable for:

1. **Disease monitoring:** Tracking changes in metabolic activity or perfusion over time to assess treatment response in conditions like cancer or heart disease.
2. **Radiotherapy planning:** Accurately determining the dose delivered to tumors and critical organs.
